Reports/Presentations

Capital Project - Mr. Duell noted the recent building condition survey, issues identified, and favorable financial timing has brought about a capital project proposal. Mr. Duell shared highlights of the project including preservation to the MS, security, HS AGRISTEAM, tennis court improvements, playgrounds, HS/PS campus traffic circulation and infrastructure improvements, for a total estimate of \$19,500,000. The funding sources would be state aid at 93.8% and use of the capital reserve. Mr. Duell shared a timeline for the project. Construction would start in April 2026 with completion in October 2026. Mr. Stevens was

thanked for chairing the Blackhawk Soar Task Force.

2024-2025 Budget Presentation – Dr. Dougherty talked about key talking points to diminish the 2.8 million budget deficit. The tax levy limit is 4.6%. The district will propose a 4.59% tax levy increase. Dr. Dougherty again stated he recommends that the BOE propose a budget of at least the tax cap percentage to voters each year to keep the district fiscally sound. Dr. Dougherty stated three vacancies will not be filled. He also noted a big savings is proposing to move to the BT Health Insurance Consortium. Dr. Dougherty provided possible options if enhanced aid is awarded. Ms. Gramstad presented on the proposed budget. She provided revenue and expenditure projections and a history of tax levy increases. A proposed 4.59% tax levy increase provides \$254,865. The proposed budget is expected to be \$23,685,320.

RESOLUTION DETERMINING THE PROPOSED ACTION IS A TYPE II ACTION FOR PURPOSES OF THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT FOR CERTAIN BUILDING AND OTHER IMPROVEMENTS FOR OXFORD ACADEMY AND CENTRAL SCHOOL DISTRICT.

WHEREAS, the Oxford Academy and Central School District (the "School District") is considering undertaking the renovation, reconstruction, improvement, rehabilitation, repair, furnishing and/or equipping of the School District's Primary School, Middle School and High School, including, but not limited to, the renovation and reconstruction of building exteriors and interiors, roof repairs, window replacement, improvement of the fire and security systems, installation of camera systems, refurbishment of HVAC, mechanical, electrical and plumbing systems, replacement and upgrades of boiler and heating systems, replacement of lighting fixtures and lighting improvements, and campus wide site improvements consisting of vehicular/pedestrian circulation improvements, redesign and improvements of parking lots, widening of existing curb cuts, ADA compliance, replacement of sidewalks and signage, and athletic facility and playground related improvements, fencing improvements, replacement and installation of generator, storm water management system improvements, and grading or improvement of the sites, and the acquisition of original furnishings, equipment, machinery and apparatus required for the purposes for which such buildings and improvements are to be used and as more particularly described on Exhibit A hereto (the "Projects"); and

WHEREAS, pursuant to the provisions of the New York State Environmental Quality Review Act ("SEQRA") as set forth in Article 8 of the Environmental Conservation Law and the requirements of the SEQRA Regulations at 6 NYCRR Part 617 (the "Regulations"), the Board of Education desires to comply with the provisions of SEQRA and the Regulations with respect to the Project; and

WHEREAS, pursuant to the Regulations, the Board of Education has considered the Projects in light of the actions included on the Type I list specified in Section 617.4 of the Regulations and in light of the actions included on the Type II list specified in Section 617.5 of the Regulations;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Oxford Academy and Central School District as follows:

Section 1. The Board hereby determines that the Projects constitute "Type II actions" (as the quoted term is defined in the Regulations) because they meet the criteria specified in 6 NYCRR Part 617.5(c)(1), (2), (3), (8), (10) and/or (31), because they involve:

- (1) maintenance or repair involving no substantial changes in an existing structure or facility;
- 2) replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site;
- (3) retrofit of an existing structure and its appurtenant areas to incorporate green infrastructure;
- (8) maintenance of existing landscaping or natural growth;
- (10) routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area...; and/or
- (31) purchase or sale of furnishings, equipment or supplies, including surplus government property,
 - Section 2. The Board hereby determines that the Projects are not subject to further review under SEQRA.

No early mail voter's "ballot" will be canvassed, unless it is received in the office of the District Clerk by 5:00 p.m. on May 21, 2024, the day of the vote. In accordance with Section 2018-f(7) of the New York Education Law, a listing of all persons to whom an early mail ballot is issued will be available for public inspection in the Office of the District Clerk during regular office hours until the day of the vote. A challenge to an early voting ballot may not be made on the basis that the voter should have applied for an absentee ballot.

NOTICE IS FURTHER GIVEN that applications for absentee ballots for the election may be obtained at the office of the District Clerk. A completed absentee ballot "application" must be received by the District Clerk at least seven (7) days before the May 21, 2024 vote (i.e. by May 14, 2024) if the absentee ballot is to be mailed to the voter, or the day before the May 21, 2024 vote (i.e. May 20, 2024) if the absentee ballot is to be delivered personally to the voter. Any qualified voter may, upon examination of such list, file a written challenge of the qualifications as a voter of any person whose name appears on such list, stating the reasons for such challenge. Such written challenge shall be transmitted by the District Clerk to the inspectors of election on the date of the vote.

Military voters may request an application to register as a qualified voter from the District Clerk.
