Superintendent's Message

Dear Blackhawk Community,

I'm happy to report that our budget situation this year is stable. However, in this period of growing costs, we will continue to be cautious with our expenditures.

Our overall budget is projected to increase by close to 9%, primarily because of the increasing costs of all goods and services. Because of this, Oxford Academy will have a 2.00% increase in its tax levy and is carefully planning how to use state aid most effectively.

What Residents will be Voting on

School district residents will go to the polls on May 16, from Noon - 8 pm, to vote on a \$22,909,507 budget for the 2023-2024 school year. Residents will decide whether to authorize the purchase of three (3) school buses. Residents will also elect two (2) school board members along with voting on the Oxford Memorial Library budget and electing one (1) member to the Oxford Memorial Library Board.

Annual Budget

Shall the proposed 2023-2024 budget in the amount of \$22,909,507 for the Oxford Academy & Central School District ("District") approved by the Board of Education on April 11, 2023 be adopted?

PROPOSITION I – BUS PURCHASES

Shall the Board of Education ("Board") of the Oxford Academy and Central School District, Chenango County, New York (the "District") be authorized to purchase three (3) 65-passenger school buses at a maximum estimated cost of \$158,333 each for a combined maximum estimated cost not to exceed \$475,000; and shall the Board be authorized to raise the specified sum for this purpose, or so much thereof as may be necessary, by levying a tax upon the taxable property of the District, to be collected in annual installments as provided in Section 416 of the Education Law; and in anticipation of such tax, to issue obligations of the District?

PROPOSITION II — LIBRARY APPROPRIATION

Shall the appropriation for the Oxford Memorial Library within the Oxford Academy and Central School district be increased by the sum of \$8,850.00 per year so that the total appropriation to the Oxford Memorial Library shall be \$168,029 which shall be raised by a tax upon the taxable property of the School District in accordance with Education Law section 259.

Annual Meeting, Budget Vote, Board Election, Bus Purchase OXFORD ACADEMY AND CENTRAL SCHOOL DISTRICT

NOTICE IS HEREBY GIVEN, that a public hearing of the qualified voters of the Oxford Academy and Central School District, Chenango County, Oxford, New York, will be held in the Oxford Academy Middle School Conference Room in said District on, May 2, 2023 at 6: 00 PM, for the presentation of the budget.

NOTICE IS HEREBY GIVEN, that the annual meeting of the qualified voters of the Oxford Academy and Central School District, towns of Oxford, ectal, Chenango County, New York, will be held at the Oxford Academy High School Library in said District on Tuesday, May 16, 2023. Voting will take place between the hours of 12:00 and 8:00 PM at which time the polls will be opened to vote by paper ballot on the following Propositions:

- 1. To adopt the annual budget of the School District for the fiscal year 2023-2024 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.
- 2. To elect Two (2) members of the Board of Education for a 3 year term commencing July 1, 2023 and expiring on June 30, 2026, to succeed Julie Gates and Betsy Locke, whose terms expire on June 30, 2023.
- 3. To authorize the Oxford Academy and Central School District to undertake the acquisition of three (3) sixty-five (65) passenger buses for the purpose of transporting students.
- 4. To authorize the annual budget for the fiscal year 2023-2024 to the Oxford Memorial Library, to be raised by taxation on the taxable property of the School District.
- 5. To elect One (1) member of the Oxford Memorial Library Board for a 5 year term commencing July 1, 2023 and expiring on June 30, 2028, to succeed Jeffrey Emerson, whose term expires on June 30, 2023.

AND FURTHER NOTICE IS HEREBY GIVEN that a copy of the statement of the amount of money which will be required to fund the School District's budget for 2023-2024, exclusive of public monies, may be obtained by any resident of the District during business hours beginning May 2, 2023, at the Oxford Academy and Central School district office between the hours of 7:30 AM- 3:30 PM, except Saturday, Sunday, or holidays.

AND FURTHER NOTICE IS HEREBY GIVEN that applications for absentee ballots will be obtainable between the hours of 7:30 AM and 3:30 PM Monday through Friday, except holidays, from the District Clerk. Completed applications must be received by the District clerk at least seven (7) days before the election if the ballot is to be mailed to the voter, or the day before the election, if the ballot is to be delivered personally to the voter. Absentee ballots must be received by the District clerk not later than 5:00 PM, on Tuesday, May 16, 2023.

A list of persons to whom absentee voters' ballots have been issued will be available for inspection to qualified voters of the District in the office of the District Clerk between the hours of 7:30 AM and 3:30 PM on weekdays prior the day set for the annual election and on May 16, 2023, the day set for the election, and said list will be posted at the polling place(s) at the election. Any qualified voter present in the polling place may object to the voting of the ballot upon appropriate grounds for making his/her challenge and the reasons therefore known to the Inspector of Election before the close of the polls.

AND FURTHER NOTICE IS HEREBY GIVEN, that the qualified voters of the School District shall be entitled to vote at said annual vote and election. A qualified voter is one who is (1) a citizen of the United States of America, (2) eighteen years of age or older, and (3) resident within the School District for a period of thirty (30) days next preceding the annual vote and election. The School district may require all persons offering to vote at the budget vote and election to provide one form of proof of residency pursuant to Education Law §2018-c. Such form may include a driver's license, a non-driver identification card, a utility bill, or a voter registration card. Upon offer of proof of residency, the School District may also require all persons offering to vote to provide their signature, printed name and address.

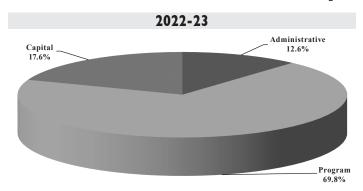

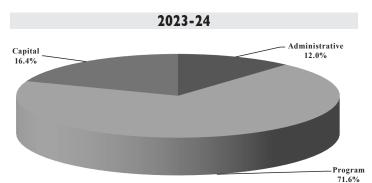

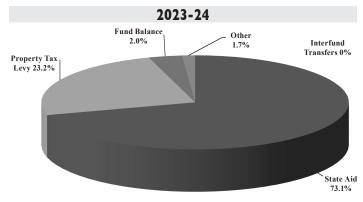

Voting Qualifications

Capital Outlay Project

OXFORD ACADEMY & CENTRAL SCHOOL DISTRICT HALL OF DISTINCTION

The Hall of Distinction was created to recognize and celebrate Oxford Academy for the accomplishments of Oxford Academy graduates and to inspire students to current and future success.

Selection Criteria: Individuals eligible for selection to the OA Hall of Distinction will have exemplified the tenets of OA's educational philosophy throughout their lives, will have been out of high school for at least 10 years and will meet one of the following:

- Outstanding social contribution to the broader community by making a difference in the lives of others.
- Outstanding professional contribution to, or achievement in, their field of endeavor.
- Outstanding achievement while a student at Oxford Academy.

Coordinating Committee: Although the school district maintains authority over all aspects of the Hall of Distinction, a Coordinating Committee will generally supervise the nomination and selection of inductees, as well as the induction ceremony. The Coordinating Committee consists of nine members: a member of the Board of Education, Superintendent, High School Principal, three teachers, two community members and one retired teacher/employee. The Coordinating

Committee may modify at will any aspect of the Hall of Distinction process, except for its Purposes and Selection Criteria. Any change in Purposes and Selection Criteria must be approved by the Board of Education.

Nomination Process: Anyone may nominate an individual for this distinction, including the individual herself/himself. A deceased individual may be nominated. An application will be eligible for consideration until the coordinating committee decides it is inactive.

Information regarding the Hall of Distinction process will appear in newspapers, the OA website, and letters to class reunions. Nomination forms will be available at the OA District Office or on the website.

Selection Process: The Coordinating Committee will review the nominations and determine the new inductees to the OA Hall of Distinction. The selection process will be based on the criteria outlined above, and all information discussed will be kept confidential.

Ceremony: The inductees will be invited to a reception and induction ceremony during Alumni weekend.

The Hall: A plaque for each inductee will be displayed in the high school auditorium lobby.
